1. **REQUEST: EXTENSION OF CUP 98-3 ENERGY FUELS COAL, INC.(SOUTHFIELD MINE)**

Request approval of an **extension of Conditional Use Permit through May 14, 2017 to complete reclamation, Department file #CUP 98-3 Energy Fuels Coal, Inc.
