Request approval of a variance of the preliminary plan requirements to allow for the creation of an outlot which will be used exclusively for water right development and facility development through the approval of a final plat, Department file #FP 12-002 Gordons Outlot 3, Acres of Ireland Filing No. 2 / SHV 12-001 Subdivision Variance, by Frances, Kenneth C. and Kenneth F.
