

Civil Mileage Fees: Rates are in accordance with C.R.S. 30-11-107 (t) and will be adjusted annually according to the prevailing Internal Revenue Service mileage reimbursement rate.

Criminal Action: Rates are based at 90% of the Internal Revenue Service mileage reimbursement rate for each mile actually and necessarily traveled.

Civil Action: **\$.54 per mile** Criminal Action: **\$48.6 per mile**
