Commissioner McFall reminded citizens about the stage 1 fire ban due to the drought conditions in Fremont County.

Debbie Oliver from the County Clerk's office gave a staff report stating that all fees had been paid and all forms filled out correctly. She said that Mr. Troutman had been unsure about the process to take due to the COVID-19 restrictions, therefore, he is asking for a waiver of the late fee.

Commissioner McFall moved to approve the Liquor License Renewal for Troutman LLC dba Bighorn Liquor as well as the late fee waiver request. Commissioner Payne seconded the motion. Request: CUP 17-001 Yevoli Cobblestone Pit
Requesting to amend condition I of Resolution 22, Series of 2019 to increase

Mark Yevoli informed the board that he is requesting to increase the amount of truck traffic from ten (10) trips a day to twenty (20) trips per day, which is consistent with other similar companies in the area.

Planning and Zoning Director Sean Garrett gave a staff report saying that the department recommends approval of the request.

Commissioner Payne moved to approve the request to amend CUP 17-001 Yevoli Cobblestone Pit condition I of Resolution 22, Series of 2019 to increase truck trips to twenty (20) per day. Current condition allows for ten (10). Resolution #47. Commissioner McFall seconded the motion. Upon Vote: Commissioner Payne, aye; Commissioner McFall, aye; Commissioner Bell, aye. The motion carried by unanimous consent.

4. Agreement between the Cañon City Area For Reinvestment Expansion, The City of Cañon City, and the Board Of County Commissioners of Fremont County for the Urban Renewal Authority

County Attorney Brenda Jackson explained in detail the County's negotiations with the City of Canon City regarding the city's intent to form an Urban Renewal Authority in order to promote future development. Ms. Jackson further explained that statute does allow for the city to do this; however, the statute does require the city to negotiate with all property taxing entities to arrive at agreements about how property taxes will be shared. She then said that the County and the City have come to an agreement that appears to be mutually beneficial.

Commissioner Bell said that there have been in-depth discussions in regards to this topic. She feels that the agreement that has been settled on is fair to all sides. Ms. Bell went on to say that this has great potential for development in Canon City which would be of benefit to all of Fremont County.

Commissioner Payne said that if the City fails to put in their fair share of the sales tax the negotiations would resume. He said that even though he has had concerns he feels that if the URA is administered properly it will help tremendously with development.

Commissioner McFall said although at first he was upset that state statute allows municipalities to force taxing entities into these situations he feels that the agreement before the Board will protect the County and its resources.

Commissioner McFall moved to approve an Agreement between the Cañon City Area For Reinvestment Expansion, The City of Cañon City, and the Board Of County Commissioners of Fremont County for the Urban Renewal Authority Commissioner Payne seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Payne, aye; Commissioner Bell, aye. The motion carried by unanimous consent.
